## **Official Rules**

Participants must be following @johnboozman on Instagram. The contest begins November 13, 2014 and ends on November 20, 2014.

### **Format/Submission Guidelines**

Photographs can be submitted by posting them to an Instagram account and tagging the photos with #Love4AR and where in Arkansas the photograph was taken.

### **Photographer/Copyright**

All entries must be original work of photographer. Entrant must solely own the copyright of any image. Submission of the photo is your guarantee that you are the author and copyright holder of the photo.

### **Number of Entries**

Individuals may submit as many photos as they would like.

### **Restrictions**

All photos must be appropriate and adhere to the following guidelines: Obscene, provocative or otherwise questionable content will be disqualified. The Office of Senator Boozman retains sole discretion as to what constitutes appropriate content. Photos that contain recognizable people will also not be considered. Photographers should either live in or have direct ties to Arkansas.

Photos will be credited to the photographer named in their instagram account. Entries will never be used for advertising or sale. If ownership of a photograph is contested, the Office of Senator Boozman retains discretion to disqualify that photograph and discontinue use of the photograph.
