

To the people of ARKANSAS

AS YOU KNOW, I HAVE ALWAYS OPPOSED AND VOTED "NO" ON OBAMACARE. AS A HEALTHCARE PROVIDER, AN OPTOMETRIST, I UNDERSTAND HEALTHCARE AND WHY THIS IS SUCH A BAD LAW.

THERE HAS BEEN A LOT OF CONFUSION OVER THE CLOTURE VOTE IN THE SENATE. I UNDERSTAND SENATE PROCEDURE IS CONFUSING, SO I WANTED TO BETTER EXPLAIN THE PROCESS.

SPENDING BILLS ORIGINATE IN THE HOUSE, WHERE CONSERVATIVE REPUBLICANS HAVE A MAJORITY. HOUSE MEMBERS PASSED A BILL THAT INCLUDED \$986 BILLION DOLLARS AND A PROVISION TO STOP GOVERNMENT FUNDS FROM BEING SPENT ON OBAMACARE. THE BILL PASSED BECAUSE CONSERVATIVES HAVE CONTROL BECAUSE THEY HAVE THE MOST VOTES. I VERY MUCH SUPPORTED THIS LEGISLATION.

THE BILL THEN CAME TO THE SENATE WHERE DEMOCRATS UNDER SEN. REID HAVE CONTROL, THEY HAVE THE MOST

votes. We had the first vote which was a cloture vote on the motion to proceed. Sounds confusing but is all it meant was that we would agree to discuss the house Bill. Everyone voted yes on this. After the discussion time ran out, we voted for cloture on the continuing resolution the House had sent over. It sounds confusing but it just meant we were voting on whether or not we would actually go ahead and vote on the house Bill. A majority of Republicans, including myself, supported this procedural vote. This was in no way a vote for Obamacare. Some Republicans voted "no" because they knew that Senator Reid would not yield to defunding Obamacare which he had worked so hard to pass and had the votes to defeat the House Bill. They wanted to go no further. I and the majority of Republicans felt it was best to have the vote and put everyone on record as to whether they were for

OR AGAINST getting rid of OBAMACARE
THEN the house could counter
with ANOTHER Bill, which is EXACTLY
what happened, with the house
countering with 1 year DELAY
of OBAMACARE which I and ALL the
Senate Republicans supported.

After the cloture vote to move
forward we had a vote on stripping
the language to defund OBAMACARE.
I voted "NO" which meant I WANTED
the defund language left in
AS DID ALL Senate Republicans. All
the Democrats voted "yes" and since
there are more Democrats it PASSED
AND the language taken out of the
bill. The next vote was a vote
~~to~~ to fund OBAMACARE while keeping
the government open. I voted
"NO" as did ALL Senate Republicans
while ALL the Democrats supported
the bill. Since the Democrats HAVE
more votes, unfortunately, the
bill PASSED. As you know the
House has MADE A NUMBER of

Sen Reid HAS REJECTED. I HAVE

I do not support the strategy of shutting down the government which is what the cloture vote to agree to vote was all about.

Many hard working Arkansans will be hurt with loss of work, late social security and veterans checks, late payment to doctors and hospitals, school free and reduced lunch, and the list goes on and on. Worse yet, Obamacare continues to move forward as most of the law's funding is mandatory.

The House and Senate should continue to negotiate and ~~reach~~ reach agreement on a continuing resolution that insures that we continue to reduce our debt and deficit.

In the past several months I have protected the second amendment, voted no on the amnesty bill in the senate and held the line on spending through the budget control act all while trying to grow the economy.
